Request for the expression of interest for the covering of teaching staff positions through direct call pursuant to Law n.230 of November 4, 2005 and subsequent amendments.

THE RECTOR

Given the Statute of the Saint Camillus International University of Health Sciences (UniCamillus);

Given the Didactic Regulations of the Saint Camillus International University of Health Sciences (UniCamillus);

Given the Law n. 168 of May 9, 1989, and in particular art. 6 pursuant to which the universities have regulatory autonomy;

Given the Law n. 243 of July 29, 1991, relating to regularly recognized non-state universities;

Given the Decree n.270 of October 22, 2004 Amendments to the regulation laying down rules concerning the didactic autonomy of universities, approved by Decree of the Minister of Universities and Scientific and Technological Research of November 3, 1999, n. 509;

Given the Law n.230 of November 4, 2005 and subsequent amendments and in particular art. 1, paragraph 9;

Given the Ministerial Decree of March 16, 2007, which determined the classes of university master's degrees;

Given the Law n. 240 of December 30, 2010, "Rules on the organization of universities, of academic staff and recruitment, as well as delegation to the Government to encourage quality and the efficiency of the university system ";

Given the Ministerial Decree n. 662 of September 1, 2016 "Definition of the correlation table between Italian and foreign academic positions referred to in Article 18, paragraph 1, letter b), of Law n. 240 of December 30, 2010";

Given the Resolution of the Organizing Technical Committee of June 21, 2020 with which it was approved the "Request for expression of interest for the covering teaching positions through direct call pursuant to Law n. 230 of November 4, 2005 and subsequent amendments ";

Consider appropriate to pursue the increase of the international profile and the strengthening of the internationalization of research and teaching;

DECREES

the approval and publication of this Notice of "Request for expressions of interest - pursuant to Law n. 230 of November 4, 2005 and subsequent amendments - for the coverage of teaching staff positions (new positions as full professor and / or associate professor) to be covered, in case of acceptance of the application, through the subsequent recruitment procedures provided for by current legislation on direct calls".

Candidates who have an interest must be in possession of one of the following requirements pursuant to law no. 230/2005 and subsequent amendments:

- To have been scholars permanently working abroad in research or teaching activities university for at least three years, with an equivalent academic position in universities or research institutions.
- The correspondences between the Italian and foreign academic positions were defined by the attachment to the Ministerial Decree n. 662/2016. The scholar's commitment abroad must be understood in one academic position covered for at least three years, possibly also in different countries and be current at the time of the proposal from the University.
- To have already carried out a period of at least three years of research and teaching in Italian universities by direct call authorized by the Ministry of University and Research as part of the "brain recovery program" and achieved scientific results consistent with the place for which the call is made.
- Be scholars who have been awarded in the context of specific high-level research programs qualification, identified by decree of the Minister of University and Research, after hearing the National Evaluation Agency of the University and Research System and the Council National University, funded by the European Union or by the Ministry of University and Research.
- To be scholars of high and recognized scientific merit, who were previously selected through national procedures, and in compliance with criteria aimed at ascertaining the excellence of individual scientific research paths.

The interested parties may submit the expression of interest, using the form available on the University website, compete with their in European format, attesting the position covered, the teaching activities, the research and the publications carried out and complete with certificate of service, issued by the home institution, with the indication of the qualification held and its effective date. All documentation must be submitted by email to the address ufficio.docenti@unicamillus.org.

The submission of the expression of interest does not give any right to admission to procedures for accessing the qualifications of University teaching staff.

This Decree will be acquired in the appropriate register of this University.
