Article 1 - Introduction

One of the fundamental prerequisites for being admitted to the University premises and being able to carry out the internship practical activity is uploading updated health documentation to the UniCamillus WebApp platform. This documentation is subsequently verified by submitting the document in its original form. To allow the Competent Doctor to carry out the appropriate checks, all the health documentation required for access to the premises and for the curricular internship must be presented in original form at the time of the medical examination. All health documentation uploaded to the UniCamillus WebApp and not verified through the original document by the UniCamillus Competent Doctor will not be taken into consideration.

The list of documentation required both for access to the University premises and for the curricular internship is subject to the evaluation of the UniCamillus Competent Doctor, responsible for the University health surveillance. Upon potential request of the Competent Doctor, the student undertakes to carry out and produce the necessary clinical tests.

N.B. For anything not covered by these regulations, please refer to the regulations of each Degree Course.

Article 2 - Access to the UniCamillus headquarters and premises

As required by the Call for applications for admission to degree courses or by the Notices for transfers to years subsequent to the first, the following health documentation is required to access the University premises:

- tuberculin test performed according to the Mantoux technique or with the Quantiferon test;
- certificate of vaccination against viral hepatitis B.

The TB test is subject to an annual expiration. The student therefore undertakes to renew the test taking into account the 12-month validity of the test.

Failure to upload and/or renew the required tests will result in a ban from university teaching activity.



Article 3 - Admission to the internship program

The certificate of professional suitability is one of the compulsory requirements for admission to the internship programme foreseen by the study plan of the relative Degree Course.

This certificate, issued by the UniCamillus Competent Doctor after a medical examination, is subject to

expiry date. Only those who have passed the medical examination may be included in the lists of students participating in the internship program.

Failure to undergo the medical examination, the non-renewal of the medical certificate or the possible unsuitability of the student will result in ineligibility for the internship.

The student undertakes to upload onto the UniCamillus WebApp all the health documentation required by the Competent Doctor. Correct uploading of the documentation enables the student to receive the summons for the medical examination. The summons always takes place via the UniCamillus WebApp.

During the medical examination, the student undertakes to present all the required health documentation in its original form. Only students with the original health documentation will be granted a medical examination. During the medical examination, the Competent Doctor will check the contents of the uploaded health documentation and, on the basis of this assessment, if they deem it necessary, will request any additions.

A specific list of medical findings is required depending on the Degree Course and the type of medical examination.

Article 4 - Disciplinary sanctions

If the documentation uploaded onto the WebApp does not appear to be in order and if the health documentation submitted during the medical examination is not the same and/or does not conform to that previously uploaded by the student onto the WebApp, the student who has submitted and/or uploaded it will be referred to the Disciplinary Board. The appropriate disciplinary measures will be taken. These may consist of the suspension and/or cancellation of the internship program or part of it, and/or a ban on taking examinations in the session immediately following the placement.



Article 5 - Health Documentation for the internship program

5.1 BSc Physiotherapy

For the BSc Physiotherapy, depending on the type of medical examination, the following health documentation is required.

First medical examination - preventive

- Routine blood chemistry tests: Glycaemia, Azotemia, Transaminases, Gamma-glutamyl Transferase (GGT), Complete blood count;
- HBV test: HBs-Ag; Anti-HBs;
- HCV test: Anti-HCV;
- Measles IgG;
- Vaccination booklet: Hepatitis B, Measles, Rubella, Mumps with two doses of MPR. Certificate of varicella infection;
- TB test: Mantoux or Quantiferon Test.

Renewal medical examination - periodic

- Routine blood chemistry tests: Glycaemia, Azotemia, Transaminases, Gamma-glutamyl Transferase (GGT), Complete blood count;

5.2 BSc Nursing

For the BSc Nursing, depending on the type of medical examination, the following health documentation is required.

First medical examination - preventive

- Routine blood chemistry tests: Glycaemia, Azotemia, Transaminases, Gamma-glutamyl Transferase (GGT), Complete blood count;
- HBV test: HBs-Ag; Anti-HBs;
- HCV test: Anti-HCV;
- Measles IgG;
- Vaccination booklet: Hepatitis B, Measles, Rubella, Mumps with two doses of MPR. Certificate of varicella infection;
- TB test: Mantoux or Quantiferon Test.



Renewal medical examination - periodic

- HBV test: HBs-Ag; Anti-HBs;

- TB test: Mantoux or Quantiferon Test.

- Routine blood chemistry tests: Glycaemia, Azotemia, Transaminases, Gamma-glutamyl Transferase (GGT), Complete blood count;
- HBV test: HBs-Ag; Anti-HBs;
- HCV test: Anti-HCV;



- Measles IgG;
- Vaccination booklet: Hepatitis B, Measles, Rubella, Mumps with two doses of MPR. Certificate of varicella infection;
- TB test: Mantoux or Quantiferon Test.

Renewal medical examination - periodic

5.5 BSc Radiology, Diagnostic Imaging and Radiotherapy Techniques

For the BSc Radiology, Diagnostic Imaging and Radiotherapy Techniques, depending on the type of medical examination, the following health documentation is required.

First medical examination - preventive

- Routine blood chemistry tests: Glycaemia, Azotemia, Transaminases, Gamma-glutamyl Transferase (GGT), Complete blood count;
- TSH, Reticulocyte count;
- Physical-chemical examination of urine;
- HBV test: HBs-Ag; Anti-HBs;
- HCV test: Anti-HCV;
- Measles IgG;
- Vaccination booklet: Hepatitis B, Measles, Rubella, Mumps with two doses of MPR. Certificate of varicella infection;
- TB test: Mantoux or Quantiferon Test.

Renewal medical examination - periodic

- Routine blood chemistry tests: Glycaemia, Azotemia, Transaminases, Gamma-glutamyl Transferase (GGT), Complete blood count;
- TSH, Reticulocyte count;
- Physical-chemical examination of urine;

5.6 MSc Medicine and Surgery

For the MSc Medicine and Surgery, depending on the type of medical examination, the following health documentation is required.

First medical examination - preventive

- Routine blood chemistry tests: Glycaemia, Azotemia, Transaminases, Gamma-glutamyl Transferase (GGT), Complete blood count;
- HBV test: HBs-Ag; Anti-HBs;
- HCV test: Anti-HCV;
- Measles IgG;
- Vaccination booklet: Hepatitis B, Measles, Rubella, Mumps with two doses of MPR. Certificate of varicella infection;
- TB test: Mantoux or Quantiferon Test.

Renewal medical examination - periodic

For the MSc Dentistry and Dental Prosthetics, depending on the type of medical examination, the following health documentation is required.

First medical examination - preventive

- Routine blood chemistry tests: Glycaemia, Azotemia, Transaminases, Gamma-glutamyl Transferase (GGT), Complete blood count;
- HBV test: HBs-Ag; Anti-HBs;
- HCV test: Anti-HCV;
- Measles IgG;
- Vaccination booklet: Hepatitis B, Measles, Rubella, Mumps with two doses of MPR. Certificate of varicella infection;
- TB test: Mantoux or Quantiferon Test.



Renewal medical examination - periodic

- Routine blood chemistry tests: Glycaemia, Azotemia, Transaminases, Gamma-glutamyl Transferase (GGT), Complete blood count;
- TB test: Mantoux or Quantiferon Test. NB On the basis of the results of previous examinations ordered by the Competent Doctor, some students may be exempted from repeating the Mantoux test or the Quantiferon test.

Article 6 - Health Documentation and data protection

With regard to the provisions on the protection of personal data as set out in Regulation EU/6792016, health records are handled in full compliance with the principles of lawfulness, correctness and transparency as well as relevance and non-excessiveness with respect to their purpose (Art. 5 GDPR).

The processing of the particular categories of personal data (relating to the state of health) of students is of exclusive competence of the University's Competent Doctor, in their capacity as autonomous Data Controller, as well as of their collaborators, all duly appointed persons authorised to process the data pursuant to and for the purposes of Article 29 of Regulation EU/679/2016 and Article 2-quaterdecies of Legislative Decree 196/2003 as amended by Legislative Decree 101/2018.

Article 7 - Final provisions

For legal and interpretation purposes, only the Regulations approved by the Organizing Technical Committee, whose original is filed at the UniCamillus Teaching Services Office and drafted in Italian, are to be regarded as authentic. A certified copy may be obtained.

For all matters not provided for in this document, reference is made to the Statute and Regulations governing the operation of the University's activities.
