**UPDATE OF THE CALL FOR APPLICATIONS FOR THE ADMISSION OF EU  
AND EQUIVALENT STUDENTS TO THE SIX-YEAR SINGLE-CYCLE MASTER'S  
DEGREE PROGRAM IN MEDICINE AND SURGERY TAUGHT IN ENGLISH AT  
THE SAINT CAMILLUS INTERNATIONAL  
UNIVERSITY OF HEALTH SCIENCES (UNICAMILLUS UNIVERSITY)  
Rome Campus - Academic Year 2025/2026  
(Approved by R.D. no. 544 of 10<sup>th</sup> October 2025)**

### **THE RECTOR**

**Given** the Statute of the Saint Camillus International University of Health Sciences (UniCamillus University);

**Given** the Academic Regulations of Saint Camillus International University of Health Sciences (UniCamillus University);

**Given** the Code of Ethics and the Organisation, Management and Control Model "231" of UniCamillus University;

**Given** The Law no. 168 of 19<sup>th</sup> May, 1989 concerning the establishment of the Ministry of the University and Scientific Research;

**Given** the Law no. 264 of 2<sup>nd</sup> August 1999, containing "Regulations on access to University courses" and subsequent amendments and integrations;

**Given** the Law no. 189 of 30<sup>th</sup> July 2002 "Amendments to the legislation on immigration and asylum" and subsequent amendments and integrations, and notably Article 26;

- Given** the Decree no. 270 of 22<sup>nd</sup> October 2004 "Amendments to the regulation containing dispositions on the didactic autonomy of the Universities", approved with Decree of the Minister of University and Scientific and Technological Research of 3<sup>rd</sup> November 1999, no. 509;
- Given** the Ministerial Decree of 16<sup>th</sup> March 2007, which has established the classification of the Degree Courses;
- Given** the "Tuition and Fees Regulation for EU and Non-EU Students of the Single-cycle Master's Degree for the A.Y. 2025/2026 – Rome Campus" approved by the Board of Directors of UniCamillus University on 18<sup>th</sup> December 2024;
- Given** the Resolution of the Board of Directors of 26<sup>th</sup> November 2024, approving the Call for applications for the admission of EU and equivalent students to the six-year Master's Degree Course in Medicine and Surgery taught in English – Rome Campus - at the Saint Camillus International University of Health Sciences (UniCamillus University) for the Academic Year 2025-2026;
- Given** the R.D. 692 of 18<sup>th</sup> December 2024, "Call for applications for the admission of EU and equivalent students to the Single-Cycle Master's degree course in Medicine and Surgery in English at the Saint Camillus International University of Health Sciences (UniCamillus) – Rome Campus – A.Y. 2025/2026;
- Given** the R.D. 144 of 1<sup>st</sup> April 2025, "Call for applications for the admission of EU and equivalent students to the Single-Cycle Master's degree course in Medicine and Surgery in English at the Saint Camillus International University of Health Sciences (UniCamillus) – Rome Campus – A.Y. 2025/2026;
- Given** the R.D. 424 of 31<sup>st</sup> July 2025, "Call for applications for the admission of EU and equivalent students to the Single-Cycle Master's degree course in Medicine and Surgery in English at the Saint Camillus International University of Health Sciences (UniCamillus) – Rome Campus – A.Y. 2025/2026;
- Considering** that as a result of the enrollment procedures for the first year of the Master's degree course in Medicine and Surgery in English at the Rome Campus of UniCamillus University – A.Y. 2025/2026, as per R.D. 106 of 11<sup>th</sup> March, 2025, per R.D. 371 of 9<sup>th</sup> July 2025 and per R.D. 511 of 29<sup>th</sup> September 2025 "Acknowledgment of the ranking list of candidates who participated in the call for applications for the admission of EU and equivalent students to the single-cycle Master's degree course in Medicine and Surgery in English at the Saint Camillus International University of Health Sciences (UniCamillus) – Rome Campus – Academic Year 2025/2026," 182 seats remain vacant.
- CONSIDERING** the need to facilitate the widest possible participation in the call for applications, published by Rector's Decree No. 544 of October 10, 2025, by the greatest possible number of candidates, by extending the deadline for the submission of applications

## DECREES

### **Article 1 (Update of Article 2 of Rector's Decree no. 544 of 10<sup>th</sup> October 2025)**

The first paragraph of Article 2 of the Application Call published pursuant Rector's Decree no. 544 of 10<sup>th</sup> October 2025 is amended as follows:

*"Registration for the admission test will be possible **until 1:00 PM on 12<sup>th</sup> December 2025**, and the €180.00 fee must be paid by the same deadline".*

### **Article 2 (Update of Article 3 of Rector's Decree no. 544 of 10<sup>th</sup> October 2025)**

The fourth paragraph of Article 3 of the Application Call published pursuant Rector's Decree no. 544 of 10<sup>th</sup> October 2025 is amended as follows:

*"The requests and the corresponding medical documentation must be submitted exclusively via certified email (PEC) to [dsa.unicamillus@pec.it](mailto:dsa.unicamillus@pec.it), no later than the application deadline for the entrance test, as indicated in Article 2 of this call (**by 1:00 PM on 12<sup>th</sup> December 2025**). The University reserves the right to carry out appropriate checks regarding the authenticity and relevance of the documentation provided".*

### **Article 3 (Update of Article 5 of Rector's Decree no. 544 of 10<sup>th</sup> October 2025)**

The fifth paragraph of Article 5 of the Application Call published pursuant Rector's Decree no. 544 of 10<sup>th</sup> October 2025 is amended as follows:

*"From the closing date for submitting applications to take the test (i.e., from 1:00 p.m. on December 12, 2025,) and throughout Monday, December 15, 2025, all candidates will receive an email from [convocazioni@ilmiotest.it](mailto:convocazioni@ilmiotest.it) sent to the email address provided during registration, containing instructions for taking the test and guidance on how to meet the technical requirements".*

### **Article 4 (Update of Rector's Decree no. 544 of 10<sup>th</sup> October 2025)**

For all matters not amended by this Decree, the Application Call approved by Rector's Decree no. 544 of 10<sup>th</sup> October 2025 shall remain in force.

This Decree is signed by hand and filed in the appropriate register of this University and published on the University website.
