Considering that as a result of the enrollment procedures for the first year of the Master's degree course in Medicine and Surgery in Italian at the Cefalù campus of UniCamillus University – A.Y. 2025/2026, as per R.D. 107 and R.D. 108 of March 11, 2025, R.D. 372 of July 9, 2025 and R.D. 513 of September 29, 2025 *"Acknowledgment of the ranking list of candidates who participated in the call for applications for the admission of EU and equivalent students to the single-cycle Master's degree course in Medicine and Surgery in Italian at the Saint Camillus International University of Health Sciences (UniCamillus) – Venice, Cefalù and Rome Campuses – Academic Year 2025/2026,"* 213 seats remain vacant.

60CONSIDERING the need to facilitate the widest possible participation in the call for applications, published by Rector's Decree No. 545 of October 10, 2025, by the greatest possible number of candidates, by extending the deadline for the submission of applications

DECREES

Article 1 (Update of Article 2 of Rector's Decree no. 545 of 10th October 2025)

The first paragraph of Article 2 of the Application Call published pursuant Rector's Decree no. 545 of 10th October 2025 is amended as follows:

*"Registration for the admission test will be possible **until 1:00 PM on 12th December 2025**, and the €180.00 fee must be paid by the same deadline".*

Article 2 (Update of Article 3 of Rector's Decree no. 545 of 10th October 2025)

The fourth paragraph of Article 3 of the Application Call published pursuant Rector's Decree no. 545 of 10th October 2025 is amended as follows:

*"The requests and the corresponding medical documentation must be submitted exclusively via certified email (PEC) to dsa.unicamillus@pec.it, no later than the application deadline for the entrance test, as indicated in Article 2 of this call (**by 1:00 PM on 12th December 2025**). The University reserves the right to carry out appropriate checks regarding the authenticity and relevance of the documentation provided".*

Article 3 (Update of Article 5 of Rector's Decree no. 545 of 10th October 2025)

The fifth paragraph of Article 5 of the Application Call published pursuant Rector's Decree no. 545 of 10th October 2025 is amended as follows:

"From the closing date for submitting applications to take the test (i.e., from 1:00 p.m. on December 12, 2025,) and throughout Monday, December 15, 2025, all candidates will receive an email from convocazioni@ilmiotest.it sent to the email address provided during registration, containing instructions for taking the test and guidance on how to meet the technical requirements".

Article 4 (Update of Rector's Decree no. 545 of 10th October 2025)

For all matters not amended by this Decree, the Application Call approved by Rector's Decree no. 545 of 10th October 2025 shall remain in force.

This Decree is signed by hand and filed in the appropriate register of this University and published on the University website.
