THE RECTOR

GIVEN the Statute of UniCamillus University of Rome;

GIVEN the Academic Regulations of the University;

GIVEN the Code of Ethics and the Organization, Management and Control Model pursuant to Legislative Decree 231/2001 of UniCamillus University;

GIVEN the Electoral Regulations for the election of student representatives of UniCamillus Degree Programs, as amended;

EVALUATED that in the elections called with Rectoral Decree No. 635/2025 there were no candidates for some degree programs in the Council of the course programme (Class Representative for the academic cohort) and Quality Assurance Group of the course programme;

EVALUATED the need to call new elections for student representatives of UniCamillus Degree Programs in the: Council of the course programme (Class Representative for the academic cohort), Quality Assurance Group of the course programme and Students-Professors Joint Committee;

DECREES

Art. 1 – Calling of elections

Art. 2 Submission of applications

Candidacies must be submitted from 00:01 (Italian time) on 26 January 2026 until 23:59 (Italian time) on 02 February 2026.

The submission of candidacies shall take place in accordance with the procedures set out in Article 7 of the Electoral Regulations.

Art. 3 – Voting procedure

Voting operations will take place in accordance with the procedures outlined in art. 9 of the Electoral Regulation.

Art. 4 – Election day

The voting system will be available during the following dates and times:

Opening of voting: 00:01 (Italian time) on 09 February 2026

Closing of voting: 23:59 (Italian time) on 10 February 2026

Once the voting period has ended, the online system will be closed and it will no longer be possible for anyone still connected to complete the voting process.

Art. 5 Electronic scrutiny operations

The Electoral Commission, once ascertained the number of voters and the regularity of voting operations, will start the scrutiny operations on 11 February 2026 as follows:
