The population examined in my research is mainly adults or adolescents with a psychiatric diagnosis or at risk of developing a psychopathological condition. My research activity benefits from the use of different methods of study peculiar to clinical psychology. A first approach consists of comparing existing models of psychopathology with empirical evidence, made possible by conducting critical and systematic literature reviews as well as meta-analyses. A second approach takes the form of the use of qualitative and/or narratological survey methodologies. They made it possible to intercept psychopathological dynamics that have been investigated in subsequent quantitative studies and/or to contextualize the results that emerged from them. Another approach is the use of physiological variables in measuring emotional regulation processes. Finally, the most consistent strand of research employs quantitative methodologies with the testing of moderation and restraint models, including through the use of structural equation models and the use of factor analysis to test the goodness-offit of clinical comprehension models and instruments for measuring psychopathological variables. Finally, a recent area of interest of mine is the use of cluster analysis and network analysis, methodologies that seem particularly well suited to account for both the heterogeneity of the psychopathological profiles investigated and the interconnectedness of transdiagnostic processes.
