THE RECTOR

HAVING CONSIDERED the Statutes of the Saint Camillus International University of Health Sciences, hereinafter referred to as UniCamillus;

HAVING CONSIDERED the Teaching Regulations;

HAVING CONSIDERED the Code of Ethics and the Organisation, Management and Control Model 231 of UniCamillus University;

HAVING CONSIDERED the granting of the Charter for Higher Education (ECHE) by the European Commission for the period 2021-2027, which is a prerequisite to apply for funding under the Erasmus+ programme;

DECLARES

Article 1

The approval and publication of the Erasmus+ Call for Applications, Study Mobility Programme for the academic year 2026-2027 for the MSc in Medicine and Surgery – Rome and Venice Campus, the text of which is attached to this Decree and constitutes an integral part thereof.

ERASMUS+ CALL FOR APPLICATIONS

FOR THE SELECTION OF STUDENTS FOR THE EU STUDY MOBILITY PROGRAMME, ACADEMIC YEAR 2026-2027

The Erasmus+ Study Mobility Programme enables university students to broaden their training opportunities, with the aim of helping them to acquire the necessary skills to facilitate their successful transition into the professional sector.

Article 1 - Purpose

UniCamillus University announces, for the academic year 2026-2027, in the framework of Key Action 1 of the Erasmus+ Programme, a selection for the allocation of international mobility places to study abroad at European partner universities with which UniCamillus has established bilateral agreements.

The mobilities foreseen in the present call are governed by the Erasmus+ Programme Regulations 2021-2027 of 28 May 2021.

Article 2 - General requirements and eligibility

This call for applications is addressed to students enrolled in the 3rd, 4th and 5th year of the MSc in Medicine and Surgery (Rome and Venice Campus) for the academic year 2025-2026, who meet the following requirements:

- a) have paid the required tuition fees for the academic year 2025-2026;
- b) have, at the time of application, a minimum number of credits equivalent to:
 - 40 ECTS credits for students enrolled in the 3rd year in the academic year 2025-26;
 - 60 ECTS credits for students enrolled in the 4th year in the academic year 2025-26;
 - 80 ECTS credits for students enrolled in the 5th year in the academic year 2025-26.
- c) hold a certificate proving appropriate language skills according to the chosen destination(s). Proven knowledge of the language(s) of the university of the destination country is required.

Specific language skills for the location(s) chosen at the time of application must be certified by official certification to be attached to the application form. For example:

- English: IELTS, TOEFL, Cambridge (FCE, CAE, CPE)
- Spanish: DELE
- French: DELF, DALF, ESABAC
- German: Goethe-Zertifikat, Zertifikat ÖSD, ZD-Zertifikat Deutsch

If, at the time of submitting the application for the Erasmus+ study mobility programme, students do not have the language certification required by the host university, they may sign a self-certification form in which they undertake to obtain this certification by **31 July 2026**. If this certificate is not provided, the student who has been awarded the study mobility grant will lose the benefit.

Students with a secondary school leaving certificate obtained abroad will be automatically classified at level C1 on presentation of their certificate (self-certifications cannot be accepted).

Article 3 - Application procedure and deadlines

The application for participation must be submitted till March 16th 2026 at 12.00 noon.

Students interested in submitting an application to participate in the Erasmus+ call for applications must access the GOMP portal (<https://unicamillus-studenti.gomp.it/Login>) with their

login details and then click on home > mobilità internazionale > studio > bando mobilità.

Once the application has been completed, the system will send confirmation of successful submission. Students can print a summary of the application and/or download a copy of the application.

Interested students may submit **a single application** in which they may select up to a maximum of three places from those listed in Annex A, in order of preference. The order of preference indicated at the time of application will be binding for the purposes of university allocation when the ranking list is drawn up, as specified in art. 5).

Please note: Submission of the application is the sole responsibility of the applicant. Applications will be considered invalid if they are:

- incomplete and/or not validated (closed) online by the time the call is closed;
- not properly completed as required by the system;
- contain false information or documentation.

It is not possible to modify or cancel applications submitted after the call is closed. Student mobility to a university in the country of residence is not allowed.

Article 4 - Criteria and evaluation of applications

For the purpose of preparing the rankings, applications submitted in compliance with the procedures and deadlines set forth in this Call will be examined by a dedicated internal Committee (composed of the University Erasmus coordinator, the Dean of the Degree Program, and the Academic Manager of the Degree Program) according to the following evaluation criteria:

- a) academic career (from 0 to 30 points);
- b) weighted average marks (from 0 to 30 points).

The final mark awarded to each application for the purpose of drawing up a ranking list will therefore be the sum of the marks awarded for points (a) and (b), up to a maximum of 60 points.

a. Academic career

The academic career will be evaluated according to the formula below, which estimates the ratio between the ECTS credits obtained during the career (up to the deadline for submission of applications) and the total number of ECTS credits that can be obtained in the year of enrolment.

ECTS credits obtained
(by the deadline for applications)

ECTS credits to be obtained
(based on the study plan of the academic year of enrolment)

Please note that the system will automatically consider as credits obtained only those actually registered in the student's record (visible on the GOMP portal) by the deadline of the call for applications.

It is the student's responsibility to check the progress of the record of recently taken examinations and to request the closure of the record in good time. For examinations taken time ago but not yet registered/closed on the GOMP portal, please contact the lecturer or the relevant Teaching Services office immediately.

According to the value obtained from the ratio expressed above (ECTS credits obtained/ECTS credits to be obtained), each student will be assigned the score (from 0 to 30) indicated in the table below.

Table a) - Score awarded for academic career

b. Weighted average marks

The score (from 0 to 30) assigned to the point value (including decimals) of the weighted average marks contributes to the final mark.

The final score for each category when the ranking list is drawn up will therefore be the sum of the scores obtained in the academic career check (a) and the weighted average check (b), up to a maximum of 60 points.

Article 5 - Ranking list

The ranking list will be published anonymously on www.unicamillus.org by 10/04/2026. Students who have duly applied will be able to consult their ranking by means of their student ID. The ranking list will indicate the position, the score obtained and, only in the case of a 'selected student', the place of assignment.

In the event of a tie, priority will be given to the student who has not benefited from international mobility during their studies. In the event of a further tie, priority will be given to the student enrolled in the oldest cohort for the academic year 2025-2026 (e.g., a student enrolled in the third year will have priority over a student enrolled in the second year). As a last resort, and again in the event of a tie, priority will be given to the student with the youngest age.

Applicants will be considered 'selected students' if they are placed in a reasonable position in terms of the number of places available at the host university. As already mentioned in art. 3), the order of priority in the choice of place, decided at the time of the application, is binding for the allocation of places. Therefore, if the student is selected for more than one place, he/she will be allocated to the place he/she has chosen, in the order of priority he/she has indicated, and will automatically forfeit the others. Thus, if the candidate is successful in all three chosen locations, he/she will be assigned to the location indicated as his/her 1st choice, forfeiting the others; if he/she is successful in the 2nd and 3rd choices, he/she will be assigned to the location indicated as his/her 2nd choice, forfeiting the others. If he/she is successful in the 3rd choice, he/she will be assigned to the same seat, forfeiting the others.

Candidates who, on the basis of the number of points obtained, are not successful because there are no more places available in the locations they have chosen, will be considered 'eligible'. In the event of an increase in the number of places available due to withdrawals and/or new agreements with other universities, the University reserves the right to rotate the eligible students according to the order of the ranking list or, if the number of places available is exhausted, to publish a new call for applications. The allocation of places for the eligible student who is the 'selected student' of the mobility programme, according to a sliding scale, will follow the same criteria already described in this article.

Therefore, when submitting an application, candidates should pay particular attention to the order of preference in the choice of host universities.

Candidates who do not meet the requirements set out in art. 2 of this notice will be considered 'ineligible'.

Please note: ranking assignment does not guarantee mobility of the student as such mobility is subject to the following conditions:

- acceptance by the host institution,
- compatibility of the study plan with the chosen semester.

Article 6 - Acceptance of the Mobility Grant

Within the deadlines indicated at the time of the publication of the rankings, the selected student of the Erasmus+ Student Mobility Grant for study purposes for the year 2026-2027 must formally accept the mobility grant by confirming the **host university** through the '**Acceptance of the destination**' function (in Italian 'Accettazione della sede') in the International Mobility section of the GOMP portal, failing which he/she will be excluded.

Once the destination has been accepted, the Erasmus Office will send the student's details to the host university within the deadlines specified by the host university.

Acceptance of mobility is a serious commitment made by the candidate. After acceptance or at the beginning of the mobility period, students may only withdraw in serious and proven cases of force majeure, to be notified in writing and duly justified, in order to allow the highest ranked reserve candidate to take over in due time.

Failure to accept within the time limit specified in this article will be considered an automatic withdrawal. In this case, the Erasmus Office will allocate the mobility to the next students in the ranking list, who may then be contacted.

Please note: The student's participation in the mobility programme is subject to acceptance or otherwise by the host university, which may reserve the right to request additional certifications/documents or even reject the application.

Article 7 - Withdrawal, acceptance and sliding scale

The selected student who has been awarded an Erasmus+ Student Mobility Grant for the academic year 2026-2027, should he/she decide to renounce the award of the grant, is required to communicate his/her withdrawal (in Italian '**Rinuncia alla Mobilità**') without delay to the Erasmus Office: erasmus@unicamillus.org. The communication must be sent exclusively through the institutional mailbox provided to each student.

The remaining places available will be allocated by moving down the ranking list or by a new call for applications. Under no circumstances will it be possible to exchange the place obtained with the place chosen by another student.

The Erasmus+ grant will be forfeited in the following cases:

- loss of student status;
- withdrawal from the Erasmus+ grant;
- any duly justified reason that renders the student ineligible to continue his/her stay abroad.

Please note: Withdrawing from an already accepted award will result in exclusion from subsequent Erasmus+ calls, unless the Erasmus+ delegate of the Degree Program evaluates otherwise based on the reasons provided.

Article 8 – Mobility

8.1 - Duration of the mobility programme

The duration of the mobility programme must be at least 2 months (equivalent to 60 days) and may reach a maximum of 24 months for MSc programmes. The mobility must also take place during the semester(s) indicated in the call for applications.

8.2 - Before the beginning of the mobility programme

Before the beginning of the mobility programme, the student must:

- Complete and sign a Learning Agreement;
- Sign a Mobility Financial Agreement;
- Renew their enrolment at UniCamillus University for the academic year 2026-2027 and pay the tuition fees by the deadline specified in the relevant Tuition fees regulations and before the start of the Erasmus mobility period. Any student who fails to complete the renewal for the academic year 2026-2027 before the start of the mobility period will forfeit the grant.

Learning Agreement (LA) – Once the grant has been formally accepted, the student must complete the official study plan, the Learning Agreement, which defines the academic activities to be carried out at the host university and guarantees the recognition of credits obtained by passing examinations.

You will need to access the Online Learning Agreement (OLA) portal at <https://learning-agreement.eu/> and create your own mobility profile, which will remain valid in the future.

The Learning Agreement completed and signed by the student must be validated by acceptance, stamped and signed by the Programme Director. In the event of non-validation by the Programme Director, the student must submit a new study plan.

This must also be approved by the relevant contact person at the host university. Acceptance by the host university is essential.

Please note that at the end of the mobility period, recognition of the examinations listed in the Learning Agreement will only be possible if they have been successfully passed.

Mobility Financial Agreement - This agreement is completed by the student upon acceptance by the chosen university. The agreement will be completed with personal and financial details and signed by the university and the student before departure. A copy will be given to the student.

8.3 – During the mobility

As soon as the student arrives at the host university, he/she must have the **Certificate of Attendance** filled in and signed by the relevant offices at the host university and send it to erasmus@unicamillus.org within 7 days of his/her arrival at the university in order to avoid delays in the payment of the grant.

- **Changes to the Learning Agreement:**

If necessary, the student may submit changes to the content of the original Learning Agreement, which must be agreed and submitted promptly (within a maximum of 10 days of arrival) for signature by the UniCamillus Programme Director and the host university.

- **Extension:**

Extension of the physical mobility period is allowed, but the total stay abroad, including the extension, must not exceed the total duration of 24 months per study cycle and must take place between 1 July 2026 and 31 July 2027.

Financial coverage for the months related to the extension is not guaranteed, but will be approved subject to the availability of European funds, provided that the request for extension is received by the Erasmus+ Office within one month after the end of the mobility initially agreed (it will not be possible to approve extensions requested after the end date of the mobility indicated in the initial agreement). It should also be noted that the extension is not guaranteed and requires the agreement of the host institution before that of the home institution.

The request must be formally submitted to the University Erasmus+ Office, which may accept or reject the request if it is not sufficiently justified or not approved by the host university. The University Erasmus+ Office will amend the Mobility Agreement upon receipt of the certificate for the additional period of study.

8.4 – Return from mobility

Within 15 days of the return from mobility, the Erasmus+ Office must receive the certificate of attendance sent by the student to erasmus@unicamillus.org in order to start the process of recognition of the credits acquired abroad.

- a) The document must be signed and stamped by the host university and must indicate the exact start and end dates of the mobility period;
- b) Transcript of Record (ToR): at the end of the mobility period, the student must ask the host university to send this document to erasmus@unicamillus.org. After receiving the ToR, the Erasmus+ Office will carry out the recognition procedure. Please note that any teaching activity carried out abroad that has not been approved by UniCamillus will not be recognised under any circumstances.

The student must also have completed the 'Participant Report' directly on the website provided by EACEA by e-mail.

Please note: The University is in no way responsible for the timing of the issue of the Transcript

of Records (ToR) by the partner universities. Please note that in some countries, documents are issued long after the end of the mobility period. Therefore, students who intend to graduate after their mobility must comply with the timetable set out in the Final Examination Regulations of their programme. If the student is unable to follow the timetable specified in the above-mentioned regulations, he/she must inform the Erasmus Office of his/her situation by emailing erasmus@unicamillus.org.

The Erasmus Office must receive the ToR at least 30 days before the beginning of the graduation session in order to allow the validation and registration of the study activity carried out abroad. After this deadline, the student will not be able to graduate in the scheduled graduation session.

Article 9 - Minimum number of ECTS credits to be acquired at the host university

On the instructions of the European Commission, UniCamillus University will require the student participating in the programme to acquire a minimum number of ECTS credits at the host university, which will be recognised by UniCamillus University in accordance with the Learning Agreement. A student studying abroad for a full year must acquire a minimum of 24 ECTS credits; a student studying abroad for six months must acquire a minimum of 12 ECTS credits; a student studying abroad for three months must acquire a minimum of 6 ECTS credits; a student studying abroad for two months must acquire a minimum of 4 ECTS credits.

Please note: When calculating the number of months/ECTS credits, the ratio 1 month = 2 ECTS credits is taken into account. If this result is not achieved, the University may not proceed with the payment of the contribution or part of it and will demand the return of any funds paid in advance, under penalty of suspension of the student's university career.

If the student fails an exam taken abroad, the examination will not generate any ECTS credits that can be recognised by this University, and therefore this examination will not be taken into account for the purposes of the ECTS credits required to obtain the payment of the contribution.

Internships within the programme will be certified by the Internship Certificate (Attendance Sheet), stamped and signed by the relevant department.

Internships can only be undertaken with prior approval if agreed in the Learning Agreement. It should also be noted that a maximum of 150 hours per semester can be recognised.

Article 10 – Student obligations and useful information

The student is responsible for completing the registration procedures required by the host university in accordance with the procedures and deadlines set out therein. The student must make his/her own accommodation arrangements for the period of study abroad or contact the host university to check the availability of student residences and/or accommodation search services.

The student must also:

- check the website of the Ministry of Foreign Affairs and International Cooperation for any safety and risk warnings concerning their destination, <https://www.viaggiaresicuri.it>;
- check and accept any mobility conditions imposed by the host university;
- take out travel insurance against cancellations or delays due to epidemics, pandemics or other force majeure;
- obtain information independently on entry visa requirements for the host university: this obligation applies in particular to non-EU and/or EU students who have to travel to a European location outside the Schengen area;

- obtain information independently about health care in the host country by contacting the local health authority or diplomatic representation. Students are encouraged to find out about health insurance in the destination country before departure. Basic health care and direct access to national health services in EU Member States is generally guaranteed by the European Health Insurance Card (EHIC). It is the student's responsibility to obtain this card if they do not already have one, if it has expired or if they have lost it. Please note that this card may cover medical assistance/repatriation costs in different ways and to different extents depending on the country of destination.
- be enrolled at UniCamillus University for the academic year 2026-2027 and pay the tuition fees by the deadline specified in the relevant Tuition fees regulations or before the start of the Erasmus mobility period. Selected students will be exempted from paying the tuition fees set by the host university.

Accident and civil liability insurance

The accident and civil liability insurance that the student benefits from when enrolling at UniCamillus is extended in the same way for the entire period spent abroad at the host institution.

Online Language Support (OLS)

Erasmus+ reinforces the support offered to participants in mobility activities to improve their foreign language skills before and during their stay abroad through a European Online Language Support (OLS) service, which offers participants in mobility activities the opportunity to assess their knowledge of the language they will use to study abroad and to take a free online language course to improve their skills. To take the test and follow the language courses, students need to register on the EU Academy platform.

Article 11 – Financial contribution

11.1 - Payment conditions for financial contribution

Financial contribution for the mobility period is granted through funds allocated by the Erasmus+ National Agency and the Italian Ministry of Universities and Research (MUR).

Mobility grants are awarded exclusively for the purpose of carrying out academic activities abroad.

Erasmus+ Mobility Grants will be awarded according to the pre-established ranking list, within the limits of the funds available. The amount of the Erasmus+ Mobility Grant varies according to the country of destination and the cost of living as follows:

The actual grant is calculated based on the number of mobility days actually spent abroad, as indicated in the Certificate of Attendance issued by the host university.

The duration of the grant is calculated according to the start and end dates of the mobility (day/month/year) using a 360-day commercial year; therefore, each month, regardless of its actual length, is considered to have 30 days. For incomplete months, the financial contribution will be calculated by multiplying the number of days of the incomplete month by 1/30 of the monthly unit cost.

The grant is paid in two instalments:

- the first, equal to 70%, at the beginning of the mobility period, after emailing erasmus@unicamillus.org the Certificate of Attendance, duly completed and signed by the partner university in the section concerning the date of arrival;
- the second, equal to 30%, at the end of the mobility period, once the Erasmus+ Office has received the Certificate of Attendance (and no later than 10 October 2026), the Transcript of Records and has verified that the expected credits have been obtained after taking and passing the exams for the agreed courses, as set out in the study plan for the mobility (Learning Agreement).

In the event of early termination of the stay abroad, the amount of the grant will be recalculated in proportion to the time actually spent abroad.

Note: Erasmus+ study mobility grants are awarded within the limits of the available financial resources and according to the criteria established by the Program (including, in particular, the duration of the mobility period, distance, and the destination country group). If the funds do not allow the financing of all mobility periods, the University may authorize additional periods of study abroad under Erasmus+ “zero grant” status, i.e., without financial contribution, while maintaining all rights associated with Erasmus status, including exemption from tuition fees at the host university and recognition of completed academic activities.

The grant payment is made exclusively via credit to a bank or postal account chosen by the beneficiary.

Payments can only be made to accounts held in the name of the grant beneficiary.

In the event of early termination of the stay abroad, the amount of the grant will be recalculated in proportion to the period actually spent.

Furthermore, if the selected student decides to stay for a shorter period of time than foreseen in the agreement (but longer than 2 months), he/she must repay part of the grant in excess of the amount received in advance. Please note that Erasmus+ grant holders who spend an actual mobility period abroad of less than 2 months (60 days) will have to return the entire amount received in advance, as they will not be entitled to any funding from the Erasmus+ project.

11.2 – Travel contribution

The Erasmus 2021-27 Program provides a contribution for Green Travel, which must be undertaken using one of the following sustainable modes of transport: bicycle, bus, carpooling, or train. Unit travel contributions for sustainable transport (eco-friendly travel) are eligible if these modes have been used for the majority of the outbound/return journey and are duly documented. Interested students will be required to keep their travel tickets, as they must be submitted at the end of the mobility period.

For a “standard” trip (by air transport), a unit contribution is provided according to the distance band: the amount paid covers the round-trip journey between the place of departure and the destination. This amount is calculated per distance band as a one-time payment.

The distance must be calculated exclusively using the tool provided by the European Commission, available at the following website: <https://erasmus-plus.ec.europa.eu/resources-and-tools/distance-calculator>

11.3 – Additional Contribution for Students with Fewer Opportunities

The Programme provides an additional top-up contribution of €250.00 per month on top of the EU individual mobility grant. This additional contribution may be awarded, subject to the availability of funds, to students who:

- have certified physical, mental, or health conditions;
- are economically disadvantaged (as certified by ISEE - ISEE threshold: €27,948.60);
- face cultural differences (e.g. individuals from a migrant background and refugees, national or ethnic minorities, persons experiencing linguistic adaptation or cultural inclusion difficulties, etc.);
- have dependent minor children;
- are employed;
- are professional athletes;
- are orphans of at least one parent;
- are children of victims of terrorism or organized crime.

Supporting documentation entitling the student to this additional contribution must be sent by email to the Erasmus+ Office at erasmus@unicamillus.org within the application deadline indicated in the Call for Applications.

11.4 – Financial contribution waiver

Acceptance of mobility, under the terms of the Agreement, is a serious commitment made by the candidate. Students who accept the EU contribution, who sign the Agreement and who subsequently intend to withdraw from the study period abroad, must fill in and send a withdrawal form and provide appropriate certification. If a certificate is not provided, or if the reasons are not considered adequate, withdrawing students will not only be required to immediately return any sums received, but will also no longer be able to apply for a grant under the programme.

Article 12 – Students with disabilities and inclusive education

In accordance with the provisions of the decision establishing the Erasmus+ Programme, the Erasmus+ National Agency INDIRE may provide an additional financial contribution to students with disabilities who apply for it, in order to widen participation in mobility programmes. These grants are awarded by the European Commission and are intended for people with specific physical, mental or health conditions. To access them, it is necessary to submit a specific request to the university's Erasmus+ office, based on the procedures and deadlines defined by the Erasmus+ National Agency INDIRE

It is standard practice for the home university to ensure that the host university makes the necessary arrangements to meet the special needs of the person concerned, provided that he/she has informed the agency of his/her physical, mental or health condition.
