



Rector's Decree no. 635 of 01 December 2025
Calling For Election Of Students' Representatives
Of Unicamillus Degree Courses in:

- the Guarantee Committee
- the Quality Assurance Group of the Course Program
- the Council of the Course Programme (Class Representative for the academic cohort)

THE RECTOR

GIVEN the Statutory of the University UniCamillus of Rome;

GIVEN the Didactic Regulation of the University;

GIVEN UniCamillus' Code of Ethics and the 231 Organisation, Management and Control Model;

GIVEN the Regulation for the election of the student representatives in the degree courses of Unicamillus;

EVALUATED that some representatives elected in previous elections, as provided by the Electoral Regulations, have ceased their duties for various reasons (completion of their degree, transfer to another university, etc.) and that, for their replacement, there are no candidates in a qualifying position on the rankings;

EVALUATED the need to call for elections of the Student Representatives of the Degree Programs at UniCamillus in the Guarantee Committee (CUG) and in the Quality Assurance Group (GAQ) of the Course Program;

EVALUATED The need to call for elections of the Student Representatives in the Council of the course programme (CdS) of all first-year Degree Programs at UniCamillus for the Academic Year 2025/2026, as well as in Degree Programs where the student representation of cohorts beyond the first has, for any reason, lapsed;

DECREES

1. Elections are called for the student representatives in the following bodies:

- **Guarantee Committee (CUG)**
1 student among all Degree Programs

- **Quality Assurance Group (GAQ) of the Degree Program**
 - 1 student for the Degree Program in Medicine and Surgery – Rome, English
 - 1 student for the Degree Program in Medicine and Surgery – Rome, Italian (first year)
 - 1 student for the Degree Program in Medicine and Surgery – Lido di Venezia
 - 1 student for the Degree Program in Medicine and Surgery – Cefalù
 - 1 student for the Degree Program in Dentistry
 - 1 student for the Degree Program in Physiotherapy
 - 1 student for the Degree Program in Midwifery
 - 1 student for the Degree Program in Nursing
 - 1 student for the Degree Program in Radiology, Diagnostic Imaging and Radiotherapy Techniques
 - 1 student for the Degree Program in Biomedical Laboratory Techniques
 - 1 student for the Degree Program in Human Nutrition Sciences
- **Council of the Course Program (Class Representative for Academic Cohort):**
 - 3 student representatives for the first year of the Degree Programs in Medicine and Surgery – Rome (in English), Medicine and Surgery – Rome (in Italian), Medicine and Surgery – Lido di Venezia, Medicine and Surgery – Cefalù, Dentistry, Nursing, and Midwifery (2025-2026 cohort regulation);
 - 2 student representatives for the first year of the Degree Programs in Physiotherapy, Medical Radiology Techniques, Imaging and Radiotherapy, Biomedical Laboratory Techniques, and Human Nutrition Sciences (2025-2026 cohort regulation);
 - 3 student representatives for the fourth year of the Degree Program in Medicine and Surgery – Rome (in English) (2022-2023 cohort regulation);
 - 1 student representative for the second year of the Degree Program in Medicine and Surgery (2024-2025 cohort regulation) at the Lido di Venezia campus;
 - 2 student representatives for the third year of the Degree Program in Medicine and Surgery (2023-2024 cohort regulation) at the Lido di Venezia campus;
 - 3 student representatives for the fourth year of the Degree Program in Dentistry and Dental Prosthetics (2022-2023 cohort regulation);
 - 1 student representative for the second year of the Master's Degree Program in Human Nutrition Sciences (2024-2025 cohort regulation).

Art. 2 Submission of applications

Candidacies must be submitted from 00:01 (Italian time) on December 5, 2025, until 23:59 (Italian time) on December 11, 2025.

The submission of candidacies shall take place in accordance with the procedures set out in Article 7 of the Electoral Regulations.

Art. 3 – Voting procedure

Voting operations will take place in accordance with the procedures outlined in art. 9 of the Electoral Regulation.

Art. 4 – Election day

The voting system will be available during the following dates and times:

Opening of voting: 00:01 (Italian time) on December 17, 2025

Closing of voting: 23:59 (Italian time) on December 18, 2025

Once the voting period has ended, the online system will be closed and it will no longer be possible for anyone still connected to complete the voting process.

Art. 5 Electronic scrutiny operations

The Electoral Commission, once ascertained the number of voters and the regularity of voting operations, will start the scrutiny operations as follows:
